PLIWA Derm V is an alcohol skin and hand disinfectant

PLIWA Derm V is an alcoholic (2-propanol v/v) skin and hand disinfectant with short exposure time without cumulative long term active ingredients.

Instructions for Use

Areas of Application

- Ideally used for:
 - Hygienic and surgical hand disinfection
 - Skin disinfection prior to simple injections and puncture of peripheral vessels,
 - Skin disinfection before surgery and before punctures of joints,
 - Disinfection of skin rich in sebum glands,
 - Cooling compresses.

Contraindications

2-Propanol 70% (v/v) is not intended for disinfection of open wounds.

Product Attributes

Composition:

- Active ingredient: 2-propanol: 63.1 g
- Other ingredients: purified water up to 100.0 g

Characteristics:

- Appearance: clear liquid
- Density at 20°C: 0.875-0.878
- Solubility in water: miscible
- Flashpoint according to DIN 51 755: 22°C
- PLIWA Derm complies wit the EU regulations of the current pharmaczopoeie with regard to "acidic and alkaline treating substances"

Shelf Life:

 The shelf life of PLIWA Derm is indicated on the container/label. After opening, the skin and hand disinfectant can be usaed for 6 months. (see over page).

Warning

Highly flammable! Keep away from sources of ignition. Do not smoke! Store tightly closed. If the soluton is spilled, immediate fire and explosion precautions must be taken. Suitable mesures include, for example, collecting the spilled liquid and diluting it with water, ventilating the room, and removing ignition sources. **Flashpoint 18°C.**

Store medicinal products out of the reach of children.



- For hyfienic hand disinfection, the hands are rubbed with the solution and kept moist for 30 seconds
- For surgical hand disinfection, hands and forearms are rubbed with the solutionand kept moist for 3 minutes.
- For disinfection prior to simle injenctions and punctures of peripheral vessels, the skin is carefully rubbed with the solution and kept moist for 15 seconds.
- For disinfection before operations and before puncturing joints, the skin is thoroughly rubbed with the solution and kept moist for 1 minute.
- For disinfection of skin rich in sebum glands, the skin is thoroughly rubbed with the solution and kept moist for 10 minutes.
- For preparatoion of cold compresses, the solution is to be diluted with equal amounts of water.

Advice

The times fiven above are minimum times. Depending on the additional difficulties (e.g., damp skin, soiling of the skin, risk of the surgery), the exposure times must be extended. 2-Propanol 70% (V/V) has no sporicidal activity and is therefore not suitable for storing sterile instruments and syringes. Adverse Reactions

Rubbing she skin with 2-propanol 70% (V/V) can cause reddening and a slight burning sensation.

If you observe any adverse reacitons, talk to your doctor or pharmacist. This also applies for adverse reactions not mentioned in this leaflet. You can also report adverse reactions directly to your country's agency that is responsible for the regulation of disinfectants. Shelf Life

- After opening, the skin and hand disinfectant can be used for 6 months. Do not use after the expiry date.
- The prerequisite is that the container must be carefully reclosed imediately after each use.
- In order to avoid contamination, remnants of infectant must not be returned to the original container once they were taken out of it.
- Decanting of ski and hand disinfectant must be carried out under aseptic conditions.
